**BASIC VISA APPLICATION REQUIREMENTS:**

For a stay of not more than 59 days

1. Passport with validity of at least six (6) months after the intended stay in the Philippines;
2. Photocopy of Identity Card;
3. Photocopy of pages of the passport containing identification data;
4. One (1) recent photograph, with signature at the back;
5. Photocopy of a round trip airline ticket, valid for his/her return to country of origin or onward journey to his/her next country of destination, or a valid visa to the next country of destination, if required.
6. Business (trading or attending seminars, training, short course studies) – letter from the sending company and the invitation from the corresponding company in the Philippines, stating the nature of travel, designation/position of the concerned official and the inclusive date of travel.
7. Official (9e visa or FGO) – Note Verbale from the Ministry of Foreign Affairs or sending foreign Embassy stating the nature of travel, designation/position of the concerned official and the inclusive dates of travel.

Additional documents are required for other categories of visitors.

Those who intend to stay for more than 59 days may apply for an extension of their visa with the Bureau of Immigration and deportation in Manila or in major cities. A minimal fee is collected.

**VISA FEES**

Single entry, valid for 3 months from the date of issue € 30.00

Multiple entry, valid for 6 months from the date of issue € 60.00

Multiple entry, valid for 12 months from the date of issue € 90.00

Visa fees subject to change without prior notice

**NO VISA REQUIRED FOR A STAY OF 21 DAYS OR LESS**

*Citizens of Belgium, the Netherlands and Luxembourg other countries not covered by Philippine visa restrictions may enter the Philippines without visa for a stay of 21 days or less. They need to present only their passports which must be valid for at least six (6) months and airline tickets with confirmed booking for their return trip or onward destination.*
